Minutes of District Level Committee (DLC) Meeting of Axom Adarxo Gram Yojana (AAGY),
Nagaon District

Venue : CONFERENCE HALL, D.C's OFFICE, NAGAON.

The meeting was presided over by Smti Kavitha Padmanabhan, IAS, Deputy Commissioner, Nagaon cum Chairperson, District Level Committee, Axom Adarxo Gram Yojana (AAGY), Nagaon District.

The Deputy Commissioner, Nagaon welcomed the Hon'ble MLAs, representatives of Hon'ble MLAs and all other members present in the meeting. The objective of the meeting was briefed by Sri Jayanta Kr. Bora, ACS, Addl. Deputy Commissioner, Nagaon.

Initiating the discussion, Deputy Commissioner, Nagaon said that in line with Govt. of India's Sansad Adarsh Gram Yojana, Axom Adarxo Gram Yojana is conceived for holistic and all-round development of village and Rs 5.00 Crore per village is earmarked and Rs 50.00 lakh is already released by the Govt. for entry level activities and as per Govt. Letter No. PD/DCP/62/2018/PT II/91, Dated 23/09/2020, fund is to be utilized by February/2021.

Matter discussed and decision taken in the meeting are summarized as follows-

- All concerned to go through the guidelines of Axom Adarxo Gram Yojana for better understanding of the scheme
- District Level Committee is formed
- Village Level Committee is to be constituted. Letter issued to concerned Block Development Officer of selected villages for submission of details of members and also asked BDOs to submit details in consultation with local Hon'ble MLAs.
- As per Govt. letter No. PD/DCP/62/2018/PT II/91, Dated 23/09/2020, Entry point activities viz. erection of entry gates, construction and up-gradation of schools and Anganwadi centers, Namghar/ Community centres, community recreation cum information centre, drinking water schemes of smaller magnitude, solar street lighting in two/three points of the selected village etc are to be completed by February/2021.
- Representative of Hon'ble MLA, Barhampur LAC said that selected village viz "Longjup 500-700 Acre" is shown to be under Barhampur LAC but actually falls under Raha LAC and requested Deputy Commissioner for modification of the village. Deputy Commissioner said that the matter will be taken up with the Govt. for inclusion of alternate village in place of Longjup 500-700 acre as per guidelines.
- Deputy Commissioner said that action plan is being prepared and meeting at village level will be held for entry point activities. DC instructed concerned HoDs to visit the villages and to hold meeting at village level for holistic development of the villages.
- For taking up schemes in the villages, concerned Hon'ble MLAs/ representatives are to be invited in village level meeting for consultation.
