Minutes of District Level Committee (DLC) Meeting of Axom Adarxo Gram Yojana (AAGY),
Nagaon District

Venue : CONFERENCE HALL, D.C.'s OFFICE, NAGAON.

The meeting was presided over by Smti Kavitha Padmanabhan, IAS, Deputy Commissioner, Nagaon cum Chairperson, District Level Committee, Axom Adarxo Gram Yojana (AAGY), Nagaon District.

The Deputy Commissioner, Nagaon welcomed the representatives of Hon'ble MLAs and all other members present in the meeting. Sri Hemanta Bhuyan, ACS, District Development Commissioner, Nagaon cum Member Secretary, DLC, Axom Adarxo Gram Yojana (AAGY) briefed the house on different aspects of guidelines, objective of the meeting through a power point presentation and explained in details of AAGY scheme.

Initiating the discussion, Deputy Commissioner, Nagaon said that in last DLC meeting held on 09/10/2020, all concerned were asked to submit list of schemes for an amount of Rs 50.00 lakh per AAGY villages (16 villages in 8 LACs) under Entry point Activities and Rs 50.00 lakh has already been released by the Govt. and as per Govt. Letter No. PD/DCP/62/2018/PT II/91, Dated 23/09/2020, fund is to be utilized by February/2021. Deputy Commissioner said that the purpose of this DLC meeting was to approve the list of schemes as proposed in Gram Sabhas and submitted by concerned Circle Officers of AAGY villages. Deputy Commissioner instructed all concerned to start works immediately after approval in DLC meeting.

Matter discussed and decision taken in the meeting are summarized as follows-


- Modification of two villages, one village i.e. "Rantholi" in place of "Mohmoria" under Nagaon Sadar LAC and one village i.e. "Kalaikhowa" in place of "Longjup 500-700 Acre" under Barhampur LAC are approved by the Govt.
- Village Level Committees are constituted and Gram Sabhas have identified schemes for entry point activities. List of schemes are submitted by concerned Circle Officer cum Chairperson of Village Level Committee and approved in District Level Committee meeting.
- Village Level Committees are instructed to open Bank Account in Nationalised Bank.
- Construction Committees will open Bank Account in Nationalised Bank after notification.
- Fund will be released in 3 installments. 1st installment (i.e. 30% of scheme fund) will be released soon and requested all concerned to start work immediately and to submit Utilization Certificate in 1st week of February and to place demand for 2nd installment.
- Regarding works to be executed by Construction Committees, demand for 2nd installment will have to be placed in Village Level Committee and Village Level Committee will place

demand in DLC for release of next installments based on satisfactory performance of the schemes.

- The Deputy Commissioner cum Chairperson of DLC, Axom Adarxo Gram Yojana (AAGY), Nagaon was empowered by the house on behalf of DLC for release of subsequent installments which will be placed for ex post facto approval in the subsequent DLC meeting. DLC also authorized DC for taking necessary action for implementation of schemes. Village wise list of schemes are enclosed as Annexure-I.


The meeting ended with vote of thanks from the chair.
