- 2. Rates must be quoted task wise, both in figures and words (type only) inclusive of all taxes.

  Over writing, cancellation etc., if any, must be initialed. (Both soft copy (in Excel format) and hard copy should be submitted). TDS will be applicable at the time payment of bills.
- 3. The Tenderer/Bidder to whom works will be allotted will have to execute a bond as per Rules and the photograph/video should be submitted along with bills.
- 4. Tenderer/Bidder must submit copies of Trade License, experience certificate, GST No. (the firm should clearly mention the GST whether Regular or Composite etc.). The PAN Card and Income Tax return acknowledgement for the Assessment year 2023-24 along with quotation.
- 5. The security money of Rs. 12,000/- (Rupees Twelve thousand) only will have to be submitted as refundable security money in the form of DD / Banker Cheque pledged in favour of the District Commissioner, Nagaon. However, the same will be forfeited in the event of any lapse, default or failure on the part of the firm to deliver quality works in time.
