NOTICE INVITING TENDER

Sealed Quotations, affixed with non-refundable Court Fee Stamps of Rs. 8.25 (Rupees Eight and Twenty- Five Paise) only, are hereby invited from the Manufacturers/Distributors/Suppliers/Owners of Country Boats for the hiring of country boats in connection with relief operations during flood situations under Raha Co-District for the year 2025-26. The rates should be quoted on a per-country boat, per-day basis, inclusive of all taxes, labour charges, and transportation costs.

Interested parties may submit their quotations as per the following format in the Tender Box at Room No. 4 of the Office of the Co-District Commissioner, Raha, during office hours only, on or before 2:00 PM on 27-05-2025. The tender will be opened on 25-05-2025 at 3:00 PM in the office chamber of the undersigned. Quotations submitted after the specified time will not be accepted under any circumstances.

Sl. No.	Type (Country Boat Capacity wise)	Rate per Day (Inclusive of Driver Charge)
1	Country boat (standard/medium) - max capacity 20 persons	
2	Country boat (big) - max capacity 60 persons	

N.B. Rates for country boats should be quoted on a per-day basis and must be specified clearly as per the prescribed format.

Particulars/ Documents required to be submitted by the bidder along with the quotation.

1. Name of the proprietor with the Firm/Owner.
2. Govt. Court fee stamp Rs. 8.25.
3. Self attested Photocopy PAN/Aadhaar Card.

Terms & Condition:

- a) The intending quotationer must quote rates specifically for the supply of country boats inclusive of driver charge.
- b) The supplier must ensure the supply of standard and specified country boats, as approved by the Tender Committee. Any substandard items will not be accepted.
- c) The country boats shall have to be supplied within 01 hour from the time of receipt of the order.
- d) The rate quoted should be inclusive of all relevant taxes, labour charge & transportation cost.
- e) Signatory of the supplier/ firm has to sign (with official seal) in each and every pages of the quotations.
- f) The approved rates will be valid for the financial year 2025-26 only.
- g) The Committee reserves the right to cancel the tender at any time.
- h) The supplier will submit bill in triplicate immediately after supply of ordered items along with the copy of Challan duly received by this office and original order copy.
- i) Payment of bill is subjected to availability of fund with the undersigned.
