## Minutes of DDC Meeting for the month of December/2021

The meeting was presided over by Sri Nisarg Hivare, IAS, Deputy Commissioner, Nagaon and assisted by Sri Hemanta Bhuyan, ACS, District Development Commissioner, Nagaon.

Initiating the discussion, the Deputy Commissioner welcomed all heads of Department.

Health	The Joint Director of Health Services reported that total registration for Antinatal Checkups (ANC) Registration (from April to November'2021) was 29,733 (67.5%) (while full ANC was 20,482 (77%)). The Deputy Commissioner wanted to know about ANC registration denominator method. The Joint Director reported that the method is Antinatal Checkup Registration/Estimated Population. The Joint Director added that village Health Nutrition Day Programme is going on. In this programme, ANM is assisted by ASHA, Anganwadi workers. The Joint Director reported that land has not been identified yet for the proposed 2 PHCs per LAC.  The Joint Director informed that COVID-19 Vaccination drive is going on and target is 25000 per day. However, it is difficult to achieve target due to reluctance of people for vaccination.	One VHND should be attended in month by Sr. MHO.  The Deputy Commissioner directed to adopt need based approach in identifying the location and submit report.  The Deputy Commissioner requested CEO, ZP to mobilize PRI members for creating awareness about vaccination drives through miking, announcing venue of vaccination and time of vaccination.
