- Non-refundable of bid processing fee of Rs.100/- (Rupees One hundred) only and EMD/Bid Security of Rs.20,000/- (Rupees twenty thousand) only are to be deposited in cash or Bank Draft pledged in favour of District Commissioner, Nagaon.
- 3. The rate should be quoted inclusive of all taxes.
- 4. The tenderer must attach the photo copy of Firm's Govt. Registration Certificate/ GST Registration Certificate, PAN Card, trade License from MB, IT returned of last 3 (three) years and Bank Account Number with the Quotation.
- 5 L1 rate for each item will be decided through the tender. All work orders will be issued in L1 rate only. For supply of each listed item, preference will be given to the bidder who has quoted L1 rate for that particular item.
- If a tenderer gets L1 rate and further he/she denies to supply that particular item, he/she will be barred from supplying the items during the entire election process.

- The approved firms must supply the equipment at the Election Branch immediately, as and when required, at their own cost.
- Rates once accepted will not be changed and will remain for hiring valid for a period of one year.

- 12. District Election Officer has the right to accept or reject any or all tenders without assigning any reason thereof and has the right to fix the price of any materials as per prevailing market rate.
