Rate will be quoted with the all taxes etc. The scope of work includes both the supply and installation of the garden, as well as its maintenance post-completion.

Details and Specifications: - The details regarding the park, garden specifications, and the scope of work can be obtained from the office of the Nagaon Zilla Parishad during working hours.

Eligibility Criteria: -

- 1) Interested nurseries must have relevant experience in similar projects.
- 2) Interested bidders must submit their business documents, including PAN and GST certificate. Additionally, it is preferable for firms to have MSME and CIH certificates.
- 3) The successful bidder will be required to maintain the garden for one year after the completion of the project.

Instructions to Bidders: -

- 1) Bidders are required to submit their quotations considering the above-mentioned scope of work.
- 2) Quotations should be submitted in sealed envelopes and must include a detailed breakdown of costs.
- 3) Bidders must ensure they meet the technical qualifications outlined to have their bids considered.
- 4) The contract will be awarded to the bidder quoting the lowest rate, provided they meet all technical qualifications.
- 5) Bidders are required to submit a tender security/bid bond of Rs. 50,000.00 (Rupees fifty thousand) along with their tender as a guarantee of earnestness. The bidder's earnest


