Order

Whereas, the Chief Executive Officer of Nagaon ZP has reported vide letter No. N.ZP.712/PE/Case/2025/4326, dated 16/07/2025 along with report of BDO, Juria Development Block vide letter No. JDB/26/Panchayat Election/2025/810 dated 08/07/2025 and Secretary, Mahguri GP vide letter No. MGP/2025-26/Alle/417, dated 05/07/2025, regarding information of minor marriage of Farida Yeasmin, elected member of Ward No 1 of Mahguri GP.

Whereas an enquiry report on this matter of the Chief Executive Officer, Nagaon Zilla Parishad vide letter No. N.ZP.712/PE/Case/2025/6703, dated 14/08/2025 stated that Farida Yeasmin was born on 30/10/1995 and that she entered into marriage when she was aged 15 years old. This establishes that the said marriage constituted a minor marriage.

Whereas, the Chief Executive Officer, Nagaon Zilla Parishad, vide letter No. N.ZP.712/PE/Case/2025/8736, dated 14/10/2025, forwarded the legal opinion of the Assistant Govt. Pleader, Nagaon, who, upon perusal of the petition filed under Section 12 of the Protection of Women from Domestic Violence Act, 2005, in Case No. Cr-2012/2012, instituted by Farida Yeasmin, daughter of Afazuddin, R/O- Udmari, under Juria Police Station, District Nagaon, as well as the judgment and order dated 08/11/2012 passed by Shri R. Dutta, JMFC, Nagaon, observed that Farida Yeasmin admitted in said case that she got married with one name Sariful Islam on 10/09/2011, in accordance with Islamic rites.

Whereas, the above act constitutes a violation of the provisions under Section 111(2) of the Assam Panchayat Act, 1994, and Rule 62(4) of the Assam Panchayat (Constitution) Rule, 1995, as amended by the above-mentioned Ward Member is bonafide.

Now, therefore, in exercise of the powers conferred under Section 111(2) of the Assam Panchayat Act, 1994 and Rule 62(4) (b) and (c) of the Assam Panchayat (Constitution) Rules 1995 as amended the Ward Member namely, Farida Yeasmin, elected member of Ward No. 1, Mahguri Gaon Panchayat, under Juria Development Block, is hereby disqualified and removed from the office of the Ward Member of Mahguri Gaon Panchayat with immediate effect.

The said seat shall be treated as vacant henceforth.
