NRA.14/2022/47= In pursuance of the order dated 25/03/2022 passed by the Hon'ble Gauhati High Court, Guwahati in connection with the WP(C)/1153/2021, applications are hereby invited in prescribed format for appointment to the post of "**REVENUE SHERISTADAR**" in the amalgamated establishment of the Deputy Commissioner, Nagaon, in the Pay Scale 30,000/- 1,10,000/-, Grade Pay 13,300/- per month plus other allowances as admissible as per the provisions of the Assam Services (ROP) Rules, 2017 and amendments thereof and under "The Assam Ministerial District Establishment Service rules, 1967" as amended.
