Notice for Invitation to conduct studies on Public Water Supply Scheme (PWSS) Electricity Expenses

The Office of the Chief Executive Officer, Nagaon Zilla Parishad invites engineering colleges within the state of Assam to undertake a comprehensive study on the electricity expenses associated with Public Water Supply Schemes (PWSS) within Nagaon district. This study has become essential due to the observation of unusually high electricity bills and significant fluctuations in these bills over three consecutive months, despite consistent water supply volumes and household numbers.

Scope of the Study

- 1. Analysis of Electricity Bills:
 - A) Conduct a detailed review of the electricity bills generated by the PWSSs.
 - B) Identify any inconsistencies or anomalies in the billing patterns.
- 2. Field Survey:
 - A) Carry out field surveys to verify the actual electricity consumption of the PWSSs.
 - B) Evaluate the efficiency of the electrical systems involved in the water supply process.
- 3. Data Interpretation and Reporting:
 - A) Provide an explanation for the observed discrepancies in electricity bills.
 - B) Suggest measures to optimize electricity consumption and reduce costs.

Submission of Proposals:

Interested engineering colleges are requested to submit a detailed proposal including-

- A) Plan of Action: Outline the methodology and approach to be adopted for the study.
- B) Cost Estimate: Provide a comprehensive estimate of the costs involved in conducting the field survey and related studies.

Financial Support:

The Office of the Nagaon Zilla Parishad will bear the actual cost required to conduct the field survey and associated studies.

Application Deadline:

All proposals should be submitted to the Office of the CEO, Nagaon Zilla Parishad by 15th September,2024.

This initiative aims to involve academic expertise in resolving a practical issue affecting the community. We look forward to active participation of engineering colleges in this important study.
